Please make sure you have.....

- Read the rules? (Please especially note those below)
No. 11 *Competitors are advised to use the services of the official accompanist but may provide their own if they wish. PLEASE NOTE: If competitors wish to use their own accompanist, no class will be delayed waiting for the accompanist to arrive.*
All “Own Choice” music must be in the hands of the Music Secretary by 1st February in the year of the Festival. No reminders will be sent and official accompanists reserve the right to refuse to play music which has not been received by the due date.
- No. 16 *In “Own Choice” classes no competitor may perform a piece already selected as a test piece in the current festival. Performers **MUST NOT SELECT** pieces which they have performed at this festival in the past two years.*
- Written names and details clearly in **BLOCK CAPITALS?**
- Completed "Own Choice" details in full (including both title and composer) and indicated if you need the Official Accompanist?
- Complied with copyright requirements.
At least one **ORIGINAL** copy of all “Own Choice” pieces **MUST** be available on the day of the Festival. Please ensure there is also a copy available for the adjudicator on the day - this can be a copy if the accompanist has an original.
- **Made sure this form has been signed by a responsible adult.**

Competitors under 12 yrs - £3.50
Competitors 17 to 21 yrs - £5.00

Competitors 12 to 16 yrs - £4.50
Competitors over 21 yrs - £6.00

Groups 12 yrs & under - £8.00 per group

Groups over 12 yrs - £10.00 per group

Please Note

- All entries for open classes will be charged at over 21years class rate.
- For duets and trios of mixed age groups the higher rate applies.
- Fees are per entry not per person - eg only one fee is paid for an entry to a duet class although there are two people performing.
